- Device Installation of Tracking Hardware(Teltonikafmb920) with One Year Software Subscription and Mobile Application.
- There will be a service charge of AED 150/each for device removal and installation in a different vehicle- (Only GPS Device).
- However, if the all vehicles are not available within 15 DAYS, we will submit the invoice for the completed job, we will not be responsible for the delay in getting the vehicle for the installation.
- Changing the device from one vehicle to another incurs a fee of 50
 AED.

Device Warranty and Repair
