- Paid upon completion of the installation or getting vehicles tracked on the system if old hardware exists.
- After one year, the software charge IoT Data Sim charges 200 QAR each vehicle

- **Software support**

- **Device Installation:**

- Device Installation of Tracking Hardware(Teltonikafmb920) with One Year Software Subscription and Mobile Application.
- There will be a service charge of QAR 150/each for device removal and installation in a different vehicle- (Only GPS Device).
- However, if the all vehicles are not available within 15 DAYS, we will submit the invoice for the completed job, we will not be responsible for the delay in getting the vehicle for the installation.
- Changing the device from one vehicle to another incurs a fee of 50 QAR.

- **Device Warranty and Repair**

- We will take care all supplied products within 1 year as an ONSITE warranty.
- We offer a one-year device replacement warranty, ensuring that any faulty devices will be replaced free of charge within the warranty period.
- One-year device service, firmware updates & hardware maintenance.

- **Device replacement:**

- In the event that the device is determined to be faulty as a result of tampering or damage caused by drivers or users, a replacement can be obtained for a fee of 150 QAR.

- **Lost or stolen vehicles:**

- If your vehicle is lost or stolen, the system can try to help you locate it by showing the location.
- We have an add-on by which vehicles can be immobilized remotely with our mobile app. We have given Immobilizer turn-on and off facility. To achieve this when installing a Teltonika GPS device we need to wire it in a certain way.
